In the frame of the Common Implementation Strategy for the Water Framework Directive (WFD) the need was identified to develop specific guidance on the application of exemptions under Article 4(7) for new modifications to the physical characteristics of water bodies and for new sustainable human development activities.

In order to kick-off the activities, a workshop is organised on 13-14 December 2016 in Brussels. The main objectives are to allow for an exchange of practical experiences on Article 4(7), clarify the common understanding, still open issues and remaining challenges which are in place.

In preparation of the workshop practical case studies were collected from across the EU. A Key Issues Paper, developed prior to the workshop using input from the MS, will guide the discussions at the workshop and serve as a basis for drafting a practical guidance document on the application of Article 4(7) in 2017.

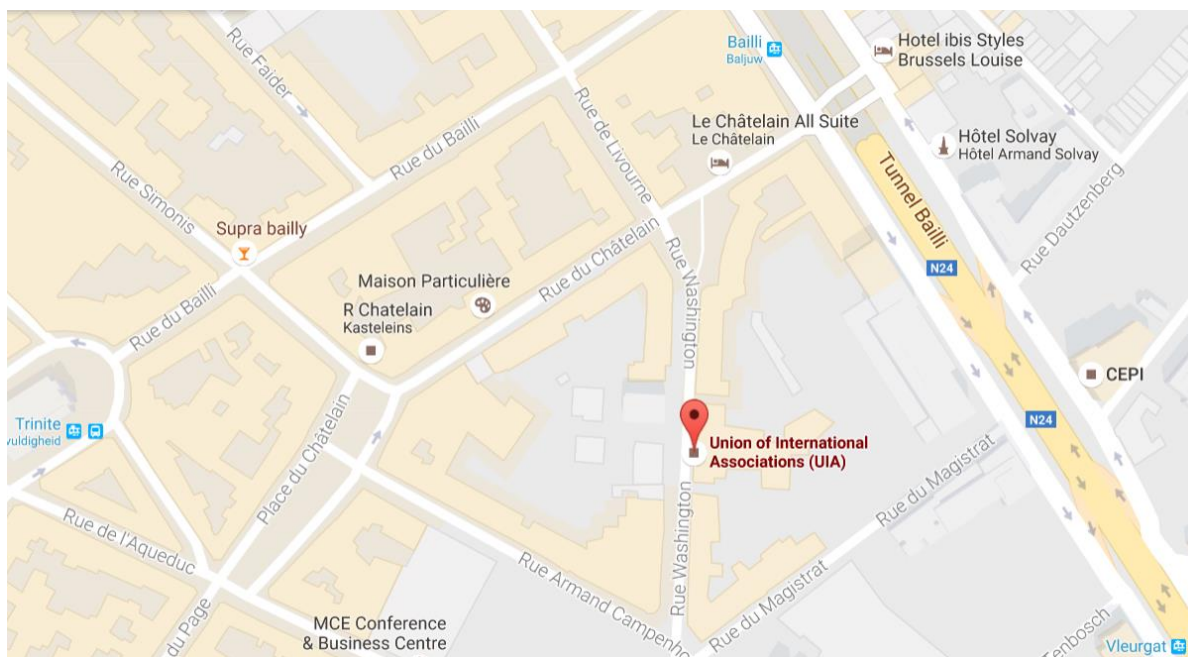
